2. Approval of Minutes: A ***motion passed*** to approve the minutes from the 04/07/22 meeting. One correction needed as Dave Kuschel has too many L’s in his name.
3. Principals Report – Stephen Eggold presented the principals report.
 - A. Enrollment is at 193 for the 2022-2023 school year K-8th. JK3 and 4 are 20. Katie Gaeta is still having tours.
 - B. Kindergarten and 6th grade are being split. First grade is at 24 which is close to being split.
 - C. The Palooza was a great success. There was \$75,000 raised the night after all the expenses. Of this \$75,000 the endowment portion was \$35,150.
 - D. There is a playground committee formed from staff members. The playground will need to be replaced soon. With money raised at the Palooza fund could go towards replacing the playground.
 - E. The search will begin for a 2nd and 6th grade teacher. The goal is to have these positions filled quickly.
 - F. A ***motion passed*** to approve the 2022-2023 budget.
4. Financial Report - Tom Johnson gave the Financial Report. The hot lunch/childcare has had a small income. The operating funds are \$110,000. Utilities and maintenance are up \$43,000 and our fundraiser fund is up to \$44,000. The end of the year is in good shape. There was a discussion asking for a designated donation by next months meeting for a new playground.
5. New Business –
 - A. Call Committee update – We currently have 6 potential candidates for the Interim Principal with 3 being interested.
 - B. Curriculum Development – This year will be back logged as we work through the leadership change.
 - C. We said farewell to Stephen Eggold, David Kuschel, Tina Meder and Jan Yaeger. We also welcomed three new members to the board – Sandy Jones and Rezart Kume from Gethsemane (present) as well as Lisa Waltenberger from Christ Memorial (not present)
